(From 03.03.25 to present - many emails regarding VV, Markets and TfNSW Rule 73) Moved Carole Andersen seconded Peter Sobey that the all inward and outward correspondence be tabled as read.

**PRESIDENT /TREASURER'S REPORT:** This report and financials were made available to all members present at this General Meeting. Peter Sobey spoke to these reports. It was moved Peter Sobey and seconded Georgette Allen that this President & Treasurer's report be accepted.

#### **GENERAL BUSINESS:**

1. TfNSW and Valla Beach Road and Giinagay Way intersection: Copies of the most recent TfNSW Media Releases available to meeting. Two received the morning of the latest bad accident on 17.06.25. Mayor Gary Lee reported that he had spoken to Michael Kemp MP this afternoon – remaining vigilant with Ministers about community involvement. Road Safety Incident Investigation Team – has become involved, hence the Al camera installation. Road safety paramount in our Valley. Mayor Gary Lee sent a scathing report to the Minister after our March Meeting. TfNSW changed the Giinagay Way without community input. VBCA to contact Gary Lee and Michael Kemp MP re any future meetings with this RSIITeam. We need our thoughts taken into. Roundabout discussed. 100 kph not good. Lowering of speed changes needed. Mention of vandalism of illuminated speed zone signs. TfNSW sourced new signs. Lighting at the intersection not good.

## **GENERAL BUSINESS (cont):**

**2. DA & Community Land - possible Hall extension project**: Report from Peter Sobey - VBCA Sub-Committee for the possible extension to our Hall; VBCA exec plus Georgette Allen and John Windmill.

Local architect Jono Ware asked to prepare draft plan – discussions needed with NVC Daniel Walsh – Peter spoke to preschool – residents' suggestion boxes at Cafes, Real Estate and Pharmacy. Hall extension would encompass higher ceilings and larger square metreage; sound acoustics installation suggested.

Mayor Gary Lee reported that from 01.07.25 new Strategic Plan will be in place – review on all community halls, community assets, grant criteria – Jocelyn Box re funding avenues – CSP actual plan for Valla Beach – budgets have been set – VBCA should write to NVC Jocelyn Box with our thoughts and plans and how to do that. Dollar for dollar grants.

# 3. Dogs on beaches:

Verbal report from Councillor Susan Jenvey to Peter Sobey – Council has 2 rangers 13 out of 14 days – 2 ranger inspections at least every day. Gary Cattanach never seen any evidence of ranger patrols – many people doing the wrong thing – Peter le Gras said that the NVC website has notes about any people digressing – difficulty with being confrontational – people letting their dogs chase birds away from their nesting areas. Recent wilful damage to 'no dog' sign.

### 4WDs on beaches:

Recent ABC News articles about damage to beaches from 4WDS – VBCA to investigate how to not allow 4WDs north to Oyster Creek – no 4WDs at Deep Creek for the estuary birds.

4WD permits obtained from the Beach Access Committee – they look at all aspects of allowances and cars – can VBCA be included in any community consultation on this subject? Discussion followed re limits on permits; blocking the access entirely. President Peter Sobey said it was an issue that keeps resurfacing and is causing community concern. Peter's suggestion was a closure of the beach to 4WD vehicles from Deep Creek to Oyster Creek. It was moved by Vanessa Wells and seconded Peter Sobey that VBCA investigate the banning of 4WDs on the beach area, north and south, by writing to the Minister for Transport. Mayor Gary Lee said that 4WD vehicles on the beach is not Council's responsibility as the beach was not controlled by Council. VBCA to write to the Minister about this issue. Mayor Gary Lee will also research this.

## 4. VBCA purchase of Carol Easton's footbridge photo:

Georgette Allen spoke on this - first suggested by Georgette at our March Meeting. Photo to be installed in our Hall - discussion re possible collage of footbridge at different stages. Georgette suggests that all future actions on this project be left to Carol Easton, when she returns, mid July. It was moved by Georgette Allen and seconded Kerri Mergan that VBCA allocates \$450 to purchase three images: 1st of the long-gone rickety bridge, 2nd of Carol's artwork (the bridge recently superseded) and 3rd (which hopefully Carol would create for us) an image of the current new bridge; and further, that the gate takings from the August market be allocated towards funding this project for our Valla Beach community. All in favour.

5. Anderson Park update: VBCA Lori Warren - report from NVC Matt Leibrandt

The skate park has recently been ground and sealed, providing a better and safer surface for skaters.

They are building a mini ramp for low entry level skaters, as a minor upgrade to the skate park. This is close to finished with the last concrete pour scheduled for 30 June and then final finish and touch-ups in a couple of weeks.

They have noted some minor drainage issues on the southern side of the sandstone walls of the netball courts, which they will look at repairing when possible.

Matt is keen to look at revisiting the proposed park plans back from 2020. He will look at getting new quotes and getting the survey completed (that was meant to happen in 2020) to help determine community preferences and needs. Having this information readily available would help if any grant options arise.

Council are getting a new communications officer on board which should also help with some of this.

# **GENERAL BUSINESS (cont):**

# 6. CRT and Defib Report Julie Collins:

Sufficient monies are now secured for new batteries for the 7 machines in 2026 – great fundraising; There was a meeting at the Nambucca Heads RSL on 01.06.25 about its evacuation centre for recent weather events. Under resourced and under prepared and brought everything that is needed to a head - talk about what resources are needed - working on storage of some resources at the VB Fire Shed. CRT team also working on information welcome packs for newcomers and/or visitors.

# 7. NVC S356 Donation Program:

Mayor Gary Lee spoke on this subject - there could possibly be an increase in relation to this Scheme from \$500 to capped at \$5,000 - NVC Jocelyn Box and Teresa Boorer are looking into this and the new Program would start in Oct/Nov of this year.

Mayor Gary Lee spoke about the current Lions Club BBQs at the Don Macrae shelter at the Valla Reserve perhaps being a recipient of this funding. One BBQ is not working at all - very expensive to replace. VBCA Peter Sobey has been liaising with Lions Club Charlie Higgins working towards an electrical upgrade for the Lions' shelter, the BBQs and also electricity to the VBCA Shed - currently waiting on a quote from Jamie Pennington Electrician. Looking to co-operation between the Lions Club, VBCA and NVC to have this area rectified.

There being no further General Business, Chairperson Peter Sobey declared the Meeting **closed at 8.20pm** - thank you all for your attendance and input.
